1. MEETING CALLED TO ORDER – MAYOR ASHLEY BRADY

<u>Councilman Ralph Atkinson to adopt Ordinance 20-10.</u> The motion carried.

3. RESOLUTION ON COVID-19 MASK REQUIRED IN PUBLIC – DISCUSSION

Mayor stated that Alan passed out handout concerning the cases in the past 14 days of Marion County and there are 128 new cases. The sheet is broken down by Counties and the City of Marion has 57 new cases, and the City of Mullins has 48 new cases. Mayor stated with the concern of the Covid-19 he thought the best thing to do would be to adopt a resolution asking our citizens to wear a mask in public. This is a resolution not an ordinance. There are no fines, and no penalties just strongly encouraging our citizens to wear a face covering mask. The Mayor read the resolution word for word. Mayor emphasized to all our citizens if they are outside and cannot keep 6 feet distance, put on mask. He also stated that it is not that difficult, and if you are in proximity in grocery store just wear a mask. A motion was made by Councilman Ralph Atkinson, seconded by **Councilwoman Tassie Lewis to approve the Resolution.** A brief discussion was held among the Council to include but not limited to the conversation to encourage everyone to wear a face mask, lead by example, sign's in businesses, and fines should be given. The motion carried. Mayor also mentioned that we have purchased a scanner for the Police department and the court room. He stated that it is basically an iPad and you would walk up to it and the iPad recognized and takes picture and you would get a red light or a green light. Green light you can enter the Police Department and court room. Red light means that you can't. Mayor also mentioned that since he has everyone together we have a City Council meeting next week and a brief discussion concerning phone call and in person meeting was discussed. Council decided to make it an option to either call in or meet in person.

Mayor also reminds everyone about the blood drive on July 16, 2020. They will run test to see if you've been exposed to COVID-19.
