V. INSURANCE REQUIREMENTS

The contractor shall maintain the following insurance policies reflecting at least the minimum amounts and conditions as follows:

Minimum Limits:

- 1) Commercial General Liability Insurance with a) Bodily injury limits of not less than \$1,000,000 each occurrence/\$2,000,000 aggregate and
- b) Property damage limits of not less than \$1,000,000 each occurrence/\$2,000,000 aggregate and
- 2) Automobile Liability Insurance with a) Not less than \$1,000,000 per incident,
- 3) Workers' Compensation Insurance in accordance with statutory requirements, and a) Employer's liability insurance with limits of not less than \$500,000 for each accident, b) \$500,000 for each disease, and c) \$500,000 aggregate.

Conditions:

- 1) Policies must be written by an insurance company authorized to do business in South Carolina.
- 2) The contractor shall include the City of Marion as an additional insured on the General Liability and Automobile Liability insurance policy required by the contract. In addition, all of the contractor's subcontractors shall be required to include the City of Marion and the contractor as additionally insured on their general liability insurance policies.

VI. TERMS AND CONDITIONS.

The City reserves the right to reject any and all proposals and to waive minor irregularities in any proposal. The City reserves the right to request clarification of the information submitted and additional information from any contractor.
